## **CEO REPORT**

Ms. Faith gave an update on the PVH nurses issue regarding not being able to vote on union representation. Ms. Faith read an email from the union which was also sent to PVH nurses and hospital staff and posted at the hospital.

There is information in the binder to review before the training session including Board Policies which require annual approval, and board subcommittees to confirm their purpose and who will serve on them.
