The first opportunity is during *Public Comments* where the public is invited to make comments on items that are not listed on the current agenda. Public comments are limited to 3 minutes per person. The Committee is scheduled to receive no more than 15 minutes of public comments in total unless the Committee approves a longer period. If more than three persons wish to address the Committee on the same topic, they are encouraged to select a spokesperson. The Committee does not take action or discuss items not appearing on the agenda.

The second opportunity for public input is before the Committee discusses and takes action on a specific Agenda item. The Petaluma Health Care District is governed by a publicly elected five-member Board of Directors to serve Southern Sonoma County, which appoints members of the Finance and Business Development Committee. Finance and Business Development Committee meetings are held the 2<sup>nd</sup> Tuesday of each month at 4:00 PM unless otherwise noticed.
