2021 was a monumental year of working with our partners to address the greatest community needs that affect health, such as the pandemic, Diversity, Equity and Inclusion, mental health support in schools, and childcare programs for working parents—and this work continues.

Also this year, following the sale of Petaluma Valley Hospital in December 2020, our staff and Board of Directors have reflected deeply on our vision, mission and strategic direction as a community-based health care district and not the hospital owner. We are listening to our partners and the community and are setting a foundation for our renewed purpose.

In this report, you'll find stories and updates on some of our programs and initiatives from this year. We are invigorated by the resilience of our team, our board and our residents, and are inspired by the many ways we know our community will move forward in the year ahead, often in spite of difficult circumstances.

In 2022, marking a 75-year milestone as a health care district, we will be rolling out major initiatives like a reinvented grant program for our local nonprofits. We are currently hiring staff for our long-awaited Community Health Worker Program who will serve as neighborhood-based advocates and educators. The program's timely introduction in southern Sonoma County is a critical response to the many forms of environmental, equity and pandemic-related trauma our community has weathered. Finally,

we are in the early stages of implementing a Blue Zones community-wide assessment in Petaluma with the city government and other key stakeholders' support and excitement.

Our work remains steadfast and we have a lot to look forward to. We wish you all a safe and joyful new year.

Navigating COVID-19

We partnered with eleven organizations across Sonoma County to receive grant funding from Partnership Healthplan of California to expand vaccine outreach and increase the number of vaccinated individuals in our county. To achieve our goal, we convened several different groups that include primary care providers, non-profit organizations and county and school representatives to form a Community Response Team in southern Sonoma County. The response team has taken action to improve the capacity of current vaccination efforts and create new opportunities for community members to get vaccinated who have previously been unable. We have aligned and strengthened local efforts to mitigate COVID-19.



2021 Key Investments in Community Health

- Portrait of Sonoma: PHCD funded South County's contribution of \$5,000 to this critical county-wide health assessment to address health disparities.
- Petaluma Educational Foundation: \$30,000 to support teachers' and students' social and emotional wellbeing through the pandemic.
- Petaluma People Services Center: In response to shifting COVID-19 distance learning schedules, PHCD leveraged \$40,000 to provide 38 families in need with scholarships for 49 students to participate in their schools' campus childcare programs during Spring 2021 Hybrid Instruction.
- Petaluma Sober Circle: Provided \$15,000 in technical and backbone support to offer wrap-around services to clients seeking a path of sobriety and secure housing.
- **Kids Scoop News:** Allocated \$5,000 to fund health education outreach to over 3,000 children through our local schools.

Total Investment in Community Health: \$200,000

Addressing Equity

Like with other communities, the effects of systemic racism exist in our community. This past year, our district was one of six health care districts that received a grant through the Wellness Foundation to participate in a series of tailored education sessions and roundtable discussions to advance our understanding of diversity, equity and inclusion (DEI). Additionally, our CEO was appointed by the Petaluma City Council to serve on the city's Ad Hoc Community Advisory Committee on Diversity, Equity and Inclusivity—a six-month commitment to engage with a diverse group of individuals in Petaluma and make recommendations to the city council to improve the city's DEI practices and policies. We've begun to utilize these conversations and trainings to advance DEI work in our community. As a community leader, we work to create spaces where all voices are included, diversity is valued, and systemic racism is eliminated.



Growing Our HeartSafe Community Program



Petaluma High School Sudden Cardiac Arrest Drill

For many years, our HeartSafe Community program has worked with our local schools to help them become HeartSafe Schools—instituting programs, trainings, AED installations and maintenance to keep all of our schools "rescue ready." This fall, Petaluma High School (PHS) took preparedness a step further to incorporate sudden cardiac arrest rescue into its ongoing drill schedule, kicking off the school year with a series of active rescue scenarios involving teachers, students and PHS's rescue team. We are thrilled to see our HeartSafe Community mission advance and commend PHS for their pioneering effort to create awareness around the need for these life-saving drills.

May Your Health Move Forward

In response to COVID safety measures and increasing feelings of isolation, we reimagined our annual Petaluma Walking Day as May Your Health Move Forward—a virtual month-long event in May co-hosted by Petaluma Parks and Recreation encouraging connection, mindfulness, and physical as well as mental wellbeing through daily guidance and encouragement delivered via social media. Guided by weekly challenges, participants were encouraged to share their steps toward better health within the event's online community. Our team was inspired by May's status as Mental Health Awareness Month to acknowledge the link between body and mind and we look forward to evolving the accessible, community-wide event for years to come!

HeartSafe Re-Designation

We celebrated the renewal of Petaluma's status as a HeartSafe City after another successful two years of meeting criteria that support increased chances of survival during cardiac emergencies outside the walls of our hospital. These criteria include widespread CPR instruction in both Spanish and English, public and private access to automated external defibrillators (AEDs), aggressive chain of survival protocol for southern Sonoma County's first responders and Petaluma Valley Hospital medical staff, and an established network of HeartSafe Community businesses and schools supported by our HeartSafe Community Advisory Committee.

About Healthquest Training Center

For nearly 40 years, PHCD's Healthquest service has been providing highquality CPR, AED (Automated External Defibrillator) and First Aid training to thousands of individuals every year and is a vendor of AEDs, parts and maintenance memberships. Healthquest is an authorized training center for the American Heart Association and manages the HeartSafe Community (HSC) initiative. Driven by the goal to strengthen the community's response to cardiac emergency, HSC continues to develop a growing network of HeartSafe businesses, schools and individuals through CPR/AED training in both Spanish and English, strategic AED installation, maintenance and registration, cardiac emergency response planning and heart health education. 
